

ANNUAL REPORT OF 2009

## **Our Partnerships/Successes**

- Six \$1000 grant awards were provided to eligible individuals pursuing higher education. The Board also expanded the program adding a \$2,500 scholarship in 2009.
- The AAA became the sponsor of the Retired and Senior Volunteer Program; expanded the program into Ashland County, and changed the name to RSVP of Mid Ohio.
- Partnered with Second Harvest Food Bank to locate a VISTA volunteer at the Area Agency on Aging (AAA) to train Ohio Benefits Bank counselors. A partnership with AARP and Mansfield/Richland Public Library located AARP volunteers at the AAA to perform Ohio Benefits Bank screenings.
- A partnership with Mansfield Memorial Homes and Richland County Foundation resulted in Mansfield Memorial Homes purchasing a specialized delivery vehicle to increase the availability of hot home delivered meals in northern Richland County.
- American Recovery and Reinvestment Act (ARRA) funds were used to provide additional meals to seniors. Almost 16,000 congregate and home delivered meals were served with this funding in the nine county district.
- Matter of Balance program was expanded to the Shelby area and Ashland, Morrow and Crawford Counties.
- The AAA became a transitions provider for the Home Choice Program, providing nursing home transition services and successfully transitioned four consumers from a nursing home to a community setting.
- Strategy Cafés were held in each county to collect information from residents and service providers for the 2011-2014 Strategic Plan.

- The AAA was one of 14 agencies, and the only one from Ohio, selected to receive a federal Supplemental Nutrition Assistance Program (SNAP) grant resulting in a partnership with local grocery stores: Cornell's IGA in Shelby, Stoodt's Market in Bellville, Hitchman's Market in Butler and Geyer's of Mansfield and Lexington to provide outreach and screening for food stamp benefits. Other partners include Primrose Retirement Communities, Elmcroft of Ontario and Richland County Job and Family Services.
- A Minority Health Commission grant was used for dental outreach to older consumers in Richland County, partnering with Third Street Family Health Services.
   68 Consumers were screened with 100% having an abnormal finding.

- AAA was selected from aging organizations nationwide to design ornaments for a White House Holiday tree in Washington, D.C. Artists from the AAA and The Mansfield Art Center designed 10 ornaments depicting local or national landmarks.
- The Richland County Senior Services Levy was passed in late 2008. The new program, Services That Assist Richland Seniors (STARS), officially began providing eligible Richland County seniors with in-home and community access and support services.

#### Our Consumers

- Care Coordination Program enrollment totaled 266 consumers.
- The PASSPORT Medicaid Waiver program served a total of 2,321 enrolled consumers.
- 6,579 Individuals contacted the AAA for an evaluation of needs.
- **3,401** people received an in-home assessment, resulting in **1,048** enrollments into AAA programs.
- **19** Facilities provided Medicaid Assisted Living Waiver services, serving **139** consumers through this program.
- Residential State Supplement (RSS) Program, providing an income supplement for Medicaid eligible adults of any age, served 16 new consumers in 2009, having a
- STARS program served 350 consumers from May to December.

# Our Advocacy

Grassroots advocacy is ongoing in the aging network to promote in-home and supportive services for seniors. This is done through letters, e-mail, visits to district offices and in Columbus by AAA staff, Board, Advisory Council and other advocates.

The AAA works with local legislators on aging issues and promotes legislators visiting consumers receiving services.

In 2009, Representative Jeff Wagner visited an Assisted Living consumer in Seneca County and Rep. Margaret Ruhl visited a PASSPORT consumer in Knox County. Rep. Jay Goyal visited the AAA on numerous occasions to discuss Ohio's long term care consumer needs.
