A Year in Review...

40TH ANNIVERSARY

- **1974 the Beginning...**the Area Agency developed a planning and service area consisting of nine counties
- Caroline Ford was the Director of the Area Agency, under the umbrella of Mansfield Memorial Homes
- **1988-89** many changes came about. The original director, Caroline Ford, retired and Patricia Brammer was named Executive Director
- **1989** by mutual agreement with Mansfield Memorial Homes, the Area Agency on Aging became a freestanding, private non-profit agency
- **1989** Area Agency became a Care Coordination Program Site – the program continues today
- **1990** the PASSPORT program became operational
- **1990** the Area Agency offices were moved from Blymyer Avenue to Marion Avenue in Mansfield to accommodate the addition of PASSPORT staff
- **1994** the Area Agency offices again relocated to 780 Park Avenue West, Mansfield due to growing staff from implementation of new programs
- **1997** Judi Saurers was appointed as the new Executive Director and served for six years
- **2003** Duana Patton was appointed and still serves as the Chief Executive Officer
- **2014** The Area Agency moved into the building that would be its permanent home, Hawkins Corner 2131 Park Avenue West, Ontario

Project Lifesaver is a Public Safety Program designed to protect and locate missing persons due to a diagnosis of wandering (no matter what their age). A radio transmitter the size of a watch when activated will assist caregivers and Richland County in locating the person.

2014 Elder Engagement

Lunch key-note speaker was Stephen Gavazzi, Dean and Director of OSU Mansfield. Otis Earl Hawkins received the first annual community legacy award for all of his philanthropic endeavors throughout the community.
